4 Report of the Secretary

During 2002 the Society intends to publish four Main Series volumes, all of which are currently in proof. Volume CXII (publication in September) will be the second and final part of David Chadd's edition of The Ordinal of the Abbey of the Holy Trinity, Fécamp. Volumes CXIII and CXIV (publication in August) will be a two-volume edition by Nicholas Orchard of The Leofric Missal (Oxford, Bodleian Library Ms Bodley 579 — vol. 1, Introduction, Collation Tables and Index; vol. 2, Text). Volume CXV (publication in August) will be Pádraig O Riain's edition of Four Irish Martyrologies (the Martyrologies of Drummond, Turin, Cashel and York, with Introductions). Council hopes to appoint the distribution of these volumes to specific subscription-years at its meeting in late April, and as soon as they have been decided the details of this distribution will be published on the 'Books Available' page of the Society's web-site. It is likely that these four volumes will between them cover all or most of the subscription-years from 1996 (for which year Volume CXI was published) to date. A current member of the Society whose own subscription history is wholly or partially incomplete for this period, but who would like to obtain any or all of these volumes, will be able to do so in return for payment of the back-subscription for the appropriate year(s). These sums will be indicated on the web-site, and payment should be made to the Society's Treasurer. Please note that we ask those not paying in Sterling to add the equivalent of £5 to their payment to cover the cost of our bank's conversion costs.

The Society's fourth *Subsidia* volume will shortly be published. Susan Twyman, *Papal Ceremonial at Rome in the Twelfth Century* examines the character and significance of the *adventus* ceremonies which were accorded to medieval popes and for which there is much evidence in the twelfth-century sources. The papal *adventus*, hitherto unstudied in any language, retained the framework and much of the familiar symbolism of the ritual reception performed for the ruler in antiquity. During the twelfth century it was performed for the popes with unprecedented frequency, providing in particular a vital part of the papal accession ritual. On such occasions *adventus* represented a demonstration of consent to rule, a sense that was expressed through traditional idioms evoking the triumph of the ruler. But the meaning of the ritual altered towards the end of the century as a result of the breakdown of relations between the papacy and the Romans, and the *adventus* provided an opportunity for the Romans to express their own agenda wherein consent meant the right of acceptance or veto by the people.

Dr Twyman's book is scheduled for publication in May 2002. It is currently the subject of a pre-publication offer by Boydell and Brewer, and an orderform is enclosed with these papers. **Please note that this offer expires on 30 April 2002.** This book will subsequently be available to current members of the Society at the usual discount, and will be included on the Members' Book Order Form.

The two *Subsidia* volumes published during 2001 are available to current members of the Society with the usual discount of 25%. Christopher A. Jones, *A Lost Work by Amalarius of Metz* costs £45/\$75 (price to non-members £60/\$110). Yitzhak Hen, *The Royal Patronage of Liturgy in Frankish Gaul to the Death of Charles the Bald (877)* costs £26.25/\$45 (price to non-members £35/\$60). Members may order one or both of these directly from Boydell & Brewer on the form enclosed, with free postage if accompanied by an order for *Papal Ceremonial*. These volumes will subsequently be obtainable by using the Members' Order Form (obtainable from the General Secretary) in the usual way.

We take this opportunity to remind members that it is the Main Series volumes only which are issued against subscriptions. *Subsidia* volumes are normally made available to members at a pre-publication discount, and thereafter at a members' discount of *ca.* 25%.

Our publishers Boydell and Brewer are kindly offering to members of the Society a discount on two further volumes appearing under their imprint. These are Sarah Hamilton, *The Practice of Penance*, 900-1050 (normal price £40/\$70: special price £30/\$52.50), and Peter Jeffery (ed.) *The Study of Medieval Chant* (normal price £50/\$85: special price £37.50/\$63.75). Orderforms, with further details of the books, are enclosed with the present papers. **Please note that this offer expires on 30 April 2002.**

5 Report of the Treasurer

The Independently Examined Accounts are again presented in close correlation with a detailed set of Management Accounts. These will, as usual, be available at the Annual Meeting, together with a statement of income and expenditure by volume.

The year 2001 was much like waiting for buses to arrive. It became clear towards the end of the year that many would arrive, but not until 2002; so the main thrust of the financial planning was to see that cash flow is optimized for a not wholly certain publication schedule.

It is not yet clear how the Euro will affect currency transactions, and whether the banks will charge fees against the Euro as such or against cheques drawn on each national banking system. It is already clear, however, that Eurocheques, even when drawn in Euros, are treated separately, so members should avoid using them.

After four years at a steady subscription rate, the Annual Meeting in 2001 approved an increase in line with inflation, to take effect from 2003. The rate will be £20.50 per annum, with a discount of £1.00 for payment without invoice.

The accounts continue to be in good health, with funds properly set aside for the ongoing support of the Society's publishing work.

INDEPENDENT EXAMINER'S REPORT ON THE ACCOUNTS

To the Officers of the Henry Bradshaw Society: As the Society's officers you are responsible for preparing the accounts; you consider that the audit and independent examination requirements of the Charities Act 1993 ("the Act") do not apply. My examination has therefore been carried out on a simplified basis designed to meet the requirements of rule 11 of the Society's constitution. The procedures undertaken do not provide all the evidence that would be relied on in an audit or full examination under the procedures specified in the General Directions given by the Charity Commissioners under section 43(7)b of the Act. Consequently I neither express an audit opinion on the view given by the accounts nor report in accordance with the General Directions issued.

The Society has elected to prepare accounts on an accruals basis consistent with Financial Reporting Standard 18. However, bank interest receivable on fixed term deposits has been accounted for on a cash received basis, contrary to the use of the accruals basis elsewhere in the accounts. In my opinion, the interest receivable should have been included, reducing the deficit for the year by approximately £30, increasing Debtors at 31 December 2000 by approximately £225 and increasing Debtors at 31 December 2001 by approximately £225.

Except for the failure to provide for bank interest receivable by the Society, in my opinion the accounts fairly reflect the state of the Society's affairs as at 31 December 2001, and of its deficit for the year then ended.
