4. Minutes of the one hundred and fifteenth Annual Meeting, 27 April 2018

The one hundred and fifteenth Annual Meeting of the Society was held on Friday 27 April 2018 at 2 p.m. in the Faculty Board Room, English Faculty, 9 West Road, Cambridge.

Those present were Professor Michael Lapidge (Vice-President, in the chair), Dr Nicolas Bell (Secretary), Dr Dan DiCenso, Dr Eleanor Giraud, Dr Helen Gittos, Professor Sarah Hamilton, Mr Christopher Hodkinson, Dr Rosalind Love, Professor Nigel Morgan, Dr David Pelteret, Professor Susan Rankin, Dr Alan Thacker, Professor Katy Cubitt and The Rev'd Canon John Toy. Dr Bernard Moreton (Treasurer) participated in the meeting via Skype.

- 1. Apologies were received from Professor David Ganz, Professor Helmut Gneuss, Prof. Ann M. Hutchison, the Rev'd Dr Michael Lang, Dom Alcuin Reid, Deacon James Scheer, Fr Anthony Ward SM and Mr W. Steven Woodward.
- 2. Commemoration was made of our departed members Patrick McGurk and Ian Doyle.
- 3. The minutes of the one hundred and fourteenth meeting were received as an accurate record and signed by the Chairman.
- 4. The Chairman was pleased to note that the Society continues to flourish, in its 128th year and with 131 publications in its catalogue. He reported that most recent publication in the Main Series, Calvin Bower's edition of *The* Liber ymnorum *of Notker Balbulus*, had received the Claude V. Palisca Award of the American Musicological Society, which is awarded to a scholarly edition or translation in the field of musicology exemplifying the highest qualities of originality, interpretation, logic and clarity of thought, and communication. He raised the possibility that the Council might choose to nominate Prof. Bower and some others to be Vice-Presidents of the Society.
- 5. The Secretary and Treasurer presented their reports, and the Treasurer circulated Book Reports for 2017. He noted that book profitability figures in the Book Reports are overstated, as they preceded the decision to sell excess copies of some volumes to a book remainder company at a discounted price. Interest rates continue at a low ebb, and so the real value of our reserves continues to shrink. It was agreed that the Society's Statement of Reserves Policy, agreed at the Council meeting of 2016, should be published in the annual accounts, and that the Risk Policy could be placed on the Society's website.
- 6. The Treasurer presented the Accounts, which had been examined by the Independent Examiner. The meeting accepted and formally approved the accounts. The Treasurer was thanked for his work in preparing them. It was agreed that the Secretary would write to Mr Patrick Clinton to thank him for his work in examining the accounts, and would file the accounts with the Charity Commission.
- 7. The election of a President to succeed Dom Cuthbert Johnson had not yet taken place. The Secretary was instructed to proceed with this matter promptly, with the assistance of the Chairman of Council.
- 8. The meeting voted unanimously that the Officers of the Council for the year 2018–19 should be as follows (proposed by David Pelteret, seconded by Nigel Morgan):

9. The meeting considered the membership of the Council. The terms of appointment of Prof. Katy

Cubitt, Prof. Sarah Hamilton and Dr David Pelteret expired at this meeting. All had expressed willingness to serve for a further period. Fr Anthony Ward, whose term of office had also expired, had written to the Secretary to inform him that he would not seek re-election. The Secretary had proposed, with Prof. Ganz seconding the proposal, that Dr Tessa Webber be appointed to the resultant vacancy. The Chairman therefore moved that Prof. Cubitt, Prof. Hamilton, Dr Pelteret and Dr Webber be appointed to serve on the Council for a term of three years, until the Annual Meeting of 2021. The Secretary agreed to write to Fr Ward to thank him for his long period of service on the Council.

- 10. The meeting considered the appointment of an Independent Examiner of the Accounts for 2018. The Treasurer reported that Mr Patrick Clinton had offered to serve in this capacity once again, and the meeting agreed unanimously to accept his kind offer.
- 11. It was agreed that the one hundred and sixteenth Annual Meeting would be held in Cambridge on Friday 26 April 2019 at 2 p.m., also to be followed by a lecture.
- 12. The meeting ended at 2.39 p.m.

5. Secretary's Report

The main activity of the Henry Bradshaw Society over the past year was the publication of the third and final volume of Nigel Morgan's edition of *English Monastic Litanies of the Saints after 1100*, which was sent out to members in May 2018 against subscriptions for the years 2013 and 2014. As well as numerous indexes and a commentary on the litanies of each religious house edited in the previous two volumes, the major portion of this volume consists of a comprehensive catalogue of the saints invoked in the litanies, including several about whom virtually nothing had previously been published.

Following the Annual Meeting in April 2018, Dr Tessa Webber delivered a lecture on 'Liturgical Books and the Medieval Library', which attracted a substantial audience. We are delighted to be able to welcome Prof. David Ganz to deliver the 2019 lecture on the earliest Gospel lectionaries, following the Annual Meeting on 26 April. The Society has also continued to sponsor the series of seminars on the history of liturgy on Monday evenings at the Institute of Historical Research in the Senate House of the University of London. The programme is posted at https://www.history.ac.uk/events/seminar/history-liturgy (with a link from the Society's website) and will be updated periodically: the final seminar of the 2018–19 academic year will be given on 20 May 2019 by our Chairman, Prof. Susan Rankin, on the subject "Antiphonarium: making and using chant books in the Early Middle Ages". These events, all of which have been free to attend, have attracted new members to the Society and, more importantly, have demonstrated a continuing and expanding interest in medieval liturgy among a wide audience. The Society's website and its Twitter account have also served to increase and expand our charitable purposes and our public benefit beyond those benefits which already apply to our members.

In the coming year we hope to publish a further volume in our Main Series, an edition by Pádraig Ó Riain of the Martyrology of the Irish monastery in Regensburg (the *Schottenkloster*), based on MS 40 of the Bischöfliche Zentralbibliothek in Regensburg. This book provides useful evidence of the veneration of Irish saints in the region around Regensburg, and of the importance which the Scottish Benedictines attached to this tradition when they were given control of the *Schottenkloster* in the early sixteenth century.

In the course of the past year the Society welcomed sixteen new members: Dr Colleen Curran (Oxford), Dr Sean Curran (Cambridge), Dr Johanna Dale (North Fambridge), Dr William Flynn (Leeds), the Rev'd Dr Alun Ford (Fen Ditton), Dr Robert Gallagher (Oxford), the Rev'd Dr Zachary M. 6 Treasurer's Report for 2018

The Independently Examined Accounts are set out below in the usual format. A statement of income and expenditure by volume will be available as usual at the Annual Meeting, together with the accounts to date for 2019


I have at last caught up with UK tax repayment claims, with the result that the 2018 accounts report two years' worth of repayments. In 2019, I hope that claims will return to normal; and stay so.

In the course of 2018 we closed our investment account with Child & Co, and transferred that balance to our CAF Gold account. The current account with Child & Co was left open, to catch any subscriptions that (despite our best endeavours over two years already) continued to be paid to the old account. There were half a dozen such payments; the subscribers have been advised; and next year I shall report formally that our connection with Child & Co, set up presumably at the foundation of the Society, has been ended.

I reported last year the imposition of warehouse stock charges, as a consequence of the decision of Boydell & Brewer to outsource their distribution, and that the Officers of the Society had taken the decision to reduce the stock of old and mostly-slow-selling volumes. A receipt from that stock disposal, and a carriage charge for the transfer of some of that stock to the Secretary, appear in the 2018 accounts.

The finances of the Society remain healthy, despite the continuing low interest rates, and well-prepared to fund the volumes in preparation.

'Statement on Reserves, approved by Council at its meeting on 26 April 2016

The Society holds no permanent endowment, and all its funds are expendable. Trustees regularly review the level of reserves required to meet the Charity's commitments to subscribers, for subscriptions received, and to editors, for volumes in various stages of preparation, and consider the consequences of a major reduction in income or increase in expenditure. Since the Society has generally issued publications in arrears to members paying subscriptions, it has been protected from the risk of amounting debts by allowing major expenditure only to follow accrual of income. The Trustees consider this policy to be sufficiently prudent in the circumstances.

The object of the Society is the advancement of religion and to educate the public in religious knowledge in particular by undertaking liturgical study and research and publishing the useful results thereof; in furtherance of these objects but no further or otherwise:
(a) to print and publish facsimiles documents rare editions and manuscripts and such other works as may be deemed desirable;
(b) to promote lectures and meetings;
(c) to acquire receive and administer any copyrights and rights in the nature of copyrights relating to the foregoing objects.
